ABOUT

Barowsky Scholars has a few different scholarship programs reaching students at different stages of pursuing higher education. The Barowsky Scholars Business School Scholarship is for students from specific geographic areas who are studying full-time to obtain their MBA at the Ross School of Business at University of Michigan, Ann Arbor.

The program is funded by Andrew P. Barowsky Foundation and administered by The Philanthropic Initiative (TPI).

THE AWARD

- Two-year, renewable scholarship to cover tuition, fees, and educational expenses at Ross School of Business at University of Michigan, Ann Arbor.
- Need and merit- based scholarship for students who are committed to building a better society.
- One scholarship of \$50,000 per year will be awarded and renewable for up to two years.

REQUIRED DOCUMENTS

The following materials are required. Only complete applications submitted online will be considered.

1. **Application Submitted Online**
2. **Resume**
3. **Letter of Recommendation**
4. **Essay**
 - Why are you interested in pursuing a career in business? What are your career goals in business and what issues do you hope to impact after obtaining your MBA.
5. **Test Scores**
6. **Transcript(s)**
7. **Financial Aid Award letter from University of Michigan.**
8. **FAFSA Submission Summary.** The ENTIRE document must be submitted. If the student has not applied for federal financial aid, please indicate in the application.

EXPECTATIONS FOR SCHOLARSHIP RENEWAL

Renewal of the scholarship is contingent upon the following:

- Students maintaining a grade point average of 3.0 or higher (on a 4.0 scale, or equivalent) and continued demonstration of financial need.

Recipients of the scholarship will be required to complete a short renewal application annually to receive the scholarship for the following academic year.

TIMELINE

- Application deadline is Monday, June 15 by 5pm.
- Scholarship recipient will be announced in July 2026.
- Scholarships will be processed in August to the University of Michigan.
